

2015 PSE&G Power Talk Sweepstakes Official Rules

OFFICIAL RULES 2016 PSE&G POWER TALK SWEEPSTAKES. NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

TIMING: The 2016 PSE&G Power Talk Sweepstakes (the “Sweepstakes”) is divided into four separate entry periods. Each Entry Period begins at 12:00 a.m. Eastern Time (“ET”), and ends at 11:59 p.m. ET. PSE&G is the official timekeeper for the Sweepstakes.

Entry Period 1: July 1 – September 30, 2016

Entry Period 2: October 1 – December 31, 2016

Entry Period 3: January 1 – March 31, 2017

Entry Period 4: April 1 – June 30, 2017

Entries received prior to or after the Entry Period will be disqualified.

ELIGIBILITY: Open only to legal residents of the State of New Jersey, who are 21 years of age or older at the time of entry. The entrants must be PSE&G customers in good standing during the entire Sweepstakes Period and at the time of the drawing. Employees, independent contractors, and any other persons or companies who receive compensation from PSE&G or their affiliates and the immediate family (spouse, civil union/domestic partners, parents and step-parents, siblings and step-siblings, and children and step-children) and household members (people who share the same residence at least three (3) months out of the year) of all such persons are not eligible to participate in this Sweepstakes. Void where prohibited.

HOW TO ENTER: During the Sweepstakes Period, you may enter the Sweepstakes in one of two ways: (i) participate in the PSE&G Power Talk online survey within the Entry Period ; or (ii) complete a 3” x 5” postcard, and mail it in a standard envelope with proper postage to: 2016 PSE&G Power Talk Sweepstakes, 505 Fifth Avenue 18th Floor, New York, NY 10017. The postcard must include your First Name, Last Name, Street Address, City, State, Zip, Phone Number, and Customer Account Number. Mail-in entries must be postmarked by September 30, 2016 for Entry Period 1, December 31, 2016 for Entry Period 2, March 31, 2017 for Entry Period 3, and June 30, 2017 for Entry Period 4. Participating in a PSE&G Power Talk online survey will not increase your chances of winning. Limit one (1) entry per PSE&G account number regardless of method of entry. In the event that multiple entries are received for the same PSE&G account number, the authorized account owner at the time of entry will be considered the entrant. All entries become the property of PSE&G and will not be acknowledged or returned. By entering, entrants acknowledge compliance with these Official Rules, including all eligibility requirements.

WINNER SELECTION: On or about October 7, 2016 for Entry Period 1, January 7, 2017 for Entry Period 2, April 7, 2017 for Entry Period 3, and July 7, 2017 for Entry Period 4, PSE&G’s designated third-party vendor will select six (6) entries for the prizes described below in a random drawing of all valid entries received. Each entrant selected will be contacted using the email address, telephone number and/or address provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). PSE&G’s decisions as to the administration and operation of the Sweepstakes and the selection

of the potential winners are final and binding in all matters related to the Sweepstakes. Potential winners will be notified on or about October 8, 2016 for Entry Period 1, January 8, 2017 for Entry Period 2, April 8, 2017 for Entry Period 3, and July 8, 2017 for Entry Period 4. Failure to respond to the winner notification survey email within five (5) days of notification will result in disqualification and selection of an alternate potential winner in a random drawing of all remaining valid entries received. Odds of winning a prize depend on the number of eligible entries received during the Sweepstakes Period.

VERIFICATION OF POTENTIAL WINNER: Potential winner must continue to comply with all terms and conditions of these Official Rules and winning is contingent upon fulfilling all requirements. The potential winner will be required to reply to and return to Sponsor, within five (5) days of the date email is sent, a winner notification survey in order to claim his/her prize. If a potential winner of any prize cannot be contacted or fails to reply to the winner notification survey within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize. In the event that a potential winner of a prize is disqualified for any reason, Sponsor may award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries.

SWEEPSTAKES CONDITIONS: This Sweepstakes is subject to these Official Rules and all applicable federal, state, and local laws and regulations. Any and all claims must be resolved in the courts of Essex County, New Jersey. By participating, entrants agree as follows: a) to abide by these Official Rules, and to the decisions of PSE&G, which shall be final and binding in all respects; b) to the use of their names and/or likenesses and/or biographical data by PSE&G and its designees if selected as the winner for advertising, promotional and other purposes in any or all media now or hereafter known throughout the world in perpetuity without compensation, permission or notification (except where prohibited by law); and c) that PSE&G shall have no liability and shall be held harmless for any damage, loss, injury or death to an entrant or any third party in connection with participation in this Sweepstakes, or the use or misuse of the Prize. PSE&G reserves the right to cancel, suspend and/or modify the Sweepstakes, or any part of it, for any reason or if any fraud, technical failures or any other factor beyond PSE&G's reasonable control impairs the integrity or proper functioning of the Sweepstakes, as determined by Sponsor in its sole discretion. PSE&G reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner.
